TEST METHOD(S)

The specimens were evaluated in accordance with the following:

ANSI/FM 4473-2011 (R2020), American National Standard for Impact Resistance Testing of Rigid Roofing Materials by Impacting with Freezer Ice

SECTION 4

MATERIAL SOURCE/INSTALLATION

Test specimens were provided by the client. Representative samples of the test specimen(s) will be retained by Intertek B&C for a minimum of four years from the test completion date.

Installation of the tested product was performed by Intertek Building & Construction (B&C). 1x2 wood battens were secured to the deck with $\#8 \times 2-1/2$ " wood screws located on 18" centers. Battens were spaced 14" on center from the bottom. Tiles were placed on the battens in overlapped weatherboard fashion and secured with $\#8 \times 2-1/2$ " located in one nail hole. Tiles overlapped 3" at the bottom and 1" at the sides.

The wood test deck was 3' wide x 4' high and constructed with 2x4 pine construction lumber at the perimeter with one stud located at the midspan. The test deck was covered with 15/32" thick plywood decking secured to the test deck with #6 x 1-5/8" screws located 2" from each end and on 6" centers.
